- (e) Finalize the parameters for deployment plan for adjustment/ distribution of existing employees in local governments and employees of Health and Education Departments in the Authorities;
- (f) Determine one time transitional grant for local governments during the year 2015-16;
- (g) Monitor progress and implementation of Interim Finance Commission Award for new local governments and Authorities;
- (h) Finalize the organogram/organizational chart for District Education and Health Authorities;
- (i) Decide about the composition of District Health & Education Authorities;
- (j) Monitor the progress of consequential amendments in the wake of repeal of PLGO, 2001; and
- (k) Supervise and guide the Divisional and District Transition Teams.
