NOTIFICATION

No.SOR(LG)8-18/2020.- In exercise of the powers conferred under section 189 of the Punjab Local Government Act 2025 (*LXXX of 2025*), Governor of the Punjab is pleased to make the following amendments in the Punjab Local Governments Land Use Plan (Classification, Reclassification and Redevelopment) Rules 2020, with immediate effect:

AMENDMENTS

In the Punjab Local Governments Land Use Plan (Classification, Reclassification and Redevelopment) Rules 2020:

1. In rule 2, in sub-rule (1), for clause (a), the following shall be substituted:
 - "(a) "Act" means the Punjab Local Government Act 2025 (*LXXX of 2025*);".
2. In rule 5, in clause (a):
 - (a) in sub-clause (xxviii), at the end, the word "and" shall be omitted; and
 - (b) in sub-clause (xxix), at the end, for the "full stop", the expression "; and" shall be substituted and thereafter, the following shall be inserted:

"(xxx) retail outlet and storage of fertilizer and pesticides."
3. In rule 6, in clause (a):
 - (a) in sub-clause (xxv), at the end, the word "and" shall be omitted; and
 - (b) in sub-clause (xxvi), at the end, for the "full stop", the expression "; and" shall be substituted and thereafter, the following shall be inserted:

"(xxvii) retail outlet, storage and manufacturing unit of fertilizer and pesticides."
4. In rule 7:
 - (a) in clause (a):
 - (i) in sub-clause (xvi), at the end, the word "and" shall be omitted; and
 - (ii) in sub-clause (xvii), at the end, for the "full

stop", the expression "; and" shall be substituted and thereafter, the following shall be inserted:

"(xviii) retail outlet and storage of fertilizer and pesticides."; and

(b) in clause (b):

- (i) in sub-clause (xxvii), at the end, the word "and" shall be omitted; and
- (ii) in sub-clause (xxviii), at the end, for the "full stop", the expression "; and" shall be substituted and thereafter, the following shall be inserted:

"(xxix) manufacturing unit of fertilizer and pesticides.".
