2. Finance Department further agrees to transfer the said funds in the PLAs (Specially opened for this purpose) of Deputy Commissioners in the Punjab to the extent the

amounts mentioned for each district Except District Bahawalpur. The funds of District Bahawalpur shall be transferred to the SDA, jointly operated by Deputy Commissioner and Additional Deputy Commissioner (General), Bahawalpur. The share of each Union Council shall be disbursed by the Deputy Commissioner / Additional Deputy Commissioner through a crossed cheque in the name of Union Council, immediately on transfer of said amounts in the PLAs/SDA.

3. The amount of Rs.100,000/- as advance share to all Rural UCs will be adjusted/deducted in four equal installments (Rs.25,000/-) from PFC share of said UCs, w.e.f February, 2018. Moreover, the said advance amount may be used specifically for removal of existing waste from villages.

4. The expenditure of Rs.1,532,600,000/- out of Rs.14,400,000,000/- will be debitale under Grant No. PC21031-Miscellaneous 01-General Public Service 014-Transfers 0141-Transfers (Inter Governmental), 014114-Union Councils, LQ5579, A05-Grants, Subsidies and Write off Loans / Advances and Others, A052-Grants Domestic A05232-Union Councils Share from Provincial allocable amount during current financial year 2017-18.
