- Certificate of registration with PCATP / PEC along with the latest renewal letter for the year 2023;
- Information / documentation regarding legal entity / copy of registration with Securities and Exchange Commission or Registrar of Firms;
- Certificate from the Federal Board of Revenue (FBR) and Punjab Revenue Authority (PRA) to the effect
  that the firm is their assesse indicating the Income Tax number and registration number with PRA for PST
  purposes;
- List of core professional staff currently working with the firm along with their C.Vs indicating projectwise experience with exact time duration for each project;
- List of projects completed by the firm during the last 10 years and similar projects in hand, indicating client, scope, cost of consultancy, documentary proof of completion or expected date of completion must be attached;
- A certificate / affidavit that the firm has not been blacklisted by any Government / Autonomous Body;
- Audited accounts for the last three financial years.

The selection of consultants shall be processed in accordance with the PPRA Rules, 2014 and amendments thereafter. The selection of Consultants would be based on Quality and Cost Based Selection (QCBS) method.
