NOTIFICATION

No.SOR(LG)5-26/2001(P-II). In exercise of the powers conferred under section 144 of the Punjab Local Government Act 2013 (XVIII of 2013) and after previous publication, Governor of the Punjab is pleased to direct that in the Punjab Local Council Servants (Service) Rules, 1997, the following amendments shall be made:

AMENDMENTS

In the Punjab Local Council Servants (Service) Rules, 1997:

- (1) For the words "Local Council", wherever occur, the words "local government" shall be substituted.
- (2) In rule 12, for the words "Zila Council", wherever occur, the words "District Council" shall be substituted.
- (3) For rule 4, the following shall be substituted:

"4. **Appointing Authority.**- (1) The authorities specified in sub-rule (2) shall be the appointing authorities for the purposes of these rules.

(2) The following shall be the appointing authorities:

(a) For the employees of Metropolitan Corporation and Municipal Corporations:

Basic Pay Scale	Appointing Authority
BPS 12 and above	Mayor
Up to BPS 11	Chief Officer

(b) For employees of Municipal Committees and District Councils:

Basic Pay Scale	Appointing Authority
BPS 12 and above	Chairman
Up to BPS 11	Chief Officer

(3) The appointing authorities shall make the appointments or promotions, as the case may be, on the recommendations of the following Selection Committees:

(4) for rule 12, the following shall be substituted:-

"12. Appeal.- A Member of Service aggrieved by an order passed against him under the rules, shall have the right to file an appeal within sixty days against said order before the Appellate Authority specified in Schedule:

Provided that the appeals pending before the District Coordination Officer prior to 1st January, 2017 under the rules shall be transferred to the Deputy Commissioner concerned for disposal."; and

- (5) for the Schedule, the following shall be substituted:
