Procurement of IT, OFFICE EQUIPMENT & OFFICE FURNITURE

Local Government and Community Development Department, Government of Punjab is implementing Punjab Intermediate Cities Improvement Investment Program (PICIIP) through Program Management Unit (PMU) and City Implementation Units (CIUs) in Sialkot and Sahiwal with financial assistance of Asian Development Bank (ADB).

1. Sealed bids are invited from Eligible Bidders, Manufacturers, Authorized Sales & Service Dealers/Distributors registered with Income Tax (Active Taxpayers list of the FBR) and Sales Tax Departments and fulfill other relevant requirements as per Provincial Laws as/if applicable for the supply of IT, Office Equipment and furniture. Bidding shall be conducted through Open Competitive Bidding (Single Stage Two Envelope) procedure specified in the Public Procurement Rules 2014 with subsequent amendments. Bids will be opened in the presence of bidders' representatives who choose to attend at 1430 hours in the Office of the undersigned, on the same date. Bids which are late, incomplete, not sealed, not signed or stamped or submitted by other than specified mode will not be considered.
4. Bid shall be cancelled if the bidder is found blacklisted by any organization at any stage during evaluation process or execution of the project.
