## **NOTIFICATION**

No.SO.Admn-III(LG)MISC/2015(P-I)/2: In continuation of this office's earlier Notification No. No.SO.Admn-III(LG)MISC/2015(P-I) dated 08-11-2019; and upon constitution of succeeding local governments under Section 3 (2) read with Section 15 of the Punjab Local Government Act (PLGA) 2019; and upon approval by the competent authority under the said Act to fix number and description of officers and servants of local governments under Section 294 read with Sections 316 (3) (4) and 320 of the said Act; and as authorized by the Punjab Cabinet in its 20<sup>th</sup> meeting dated 05-11-2019 to sort out and decide all affairs for smooth financial transition from the defunct local governments to the succeeding local governments in Punjab, the following Interim Schedule of Establishment (ISOE) (Part-2) is hereby notified for the succeeding local governments for the reasons/ purposes stated below:

- a) As the bank accounts of the succeeding local governments are yet to be opened for the stipulated four Funds under the PLGA 2019; and
- b) that during such period the succeeding local governments shall have to incur expenditure to discharge their liabilities/responsibilities of paying salaries, pensions and utility charges etc. and receive rents, fee, toll, taxes, PFC share and all other such receivable and recoverable moneys; and
- c) that the Punjab Cabinet in its 20<sup>th</sup> meeting dated 05-11-2019 has permitted that the accounts of defunct local governments shall remain operational for a period of two months i.e. until 05-01-2020 for the purposes as stated above;
- d) that in order to operate the existing bank accounts of the defunct local governments, the posts of existing competent authorities for the operation of such bank accounts of defunct local government shall be required to continue. Such posts already exist in the ISOE (Part-1), as already notified by the LG&CD Department vide Notification referred to above, of all succeeding local governments except for the posts which shall operate the bank accounts of defunct local government i.e. 'District Council'.
- 2. In view of the above, the following posts are hereby created in the succeeding local governments in order to enable smooth operation of the bank accounts of defunct 'District Councils':

\*NOTE: In case of Rawalpindi, Multan, Faisalabad, Gujranwala, Bahawalpur and other bigger cities, where areas of City (revenue) Tehsils of such districts have been included in the local area of a metropolitan corporation or a municipal corporation then the Tehsil Councils of their Sadar Tehsils shall be considered as 'Tehsil Councils of the District HQ Tehsil' for the purposes of this Notification.

3. It is, however, clarified that no substantial posting of any officer from any service shall be made against the posts mentioned at para 2 above. The competent authority shall assign additional charge of these posts to other officers for the purposes of proper operation of existing bank accounts of defunct local government i.e. 'District Council' till such bank accounts of defunct 'District Council' are closed as per instructions issued by LG&CD Department in consultation with the Finance Department. It is further clarified that there shall be no financial implication of the posts created under the ISOE (Part-2), and these posts shall remain valid till 05-01-2020.
