**NOTIFICATION**

No. SOR(LG)38-6/2015. In exercise of the powers conferred under section 191 of the Punjab Local Government Ordinance, 2001 (XIII of 2001) and after previous publication, Governor of the Punjab is pleased to direct that in the Punjab Local Governments District Service (Tehsil/Town Municipal Administration Cadre) Rules, 2005, the following amendments shall be made:

**AMENDMENTS**

In the Punjab Local Governments District Service (Tehsil/Town Municipal Administration Cadre) Rules, 2005:

- (a) in rule 13, in sub-rule (1), for clause a), the following shall be substituted:
  - "a) on such date, after completion of twenty five years of service, qualifying for pension and other retirement benefits, as the Appointing Authority may direct; or";
- (b) in rule 14, in sub-rule (1), the expression, "In addition to these remuneration and allowances, he will get 30% of the basic salary in lieu of pension per month." shall be omitted;
- (c) in rule 15, for sub-rule (1), the following shall be substituted:

"(1) The Board shall determine the pension and gratuity of members of the service on retirement.";
- (d) in Table-I:
  - (i) at Sr. No. 11-A, in column No. 7, after the words "Sub Engineers", the expression "of Local Councils Service and Tehsil/ Town Municipal Administration Cadre" shall be inserted; and
  - (ii) at Sr. No. 12, in column No. 7, in clause (c), after the expression "(BS-16)", the expression "of Local Councils Service and Tehsil/ Town Municipal Administration Cadre" shall be inserted.
