ORDER

NO.SO-ADMN-II(LG)9-354/2011(A):- In pursuance of approval of Chief Minister and concurrence of the Finance Department, sanction is hereby accorded for the up-gradation of the following posts as personal to the present incumbents in relaxation of ban on up-gradation of posts subject to the condition that the additional financial liability will be borne by the concerned Local Government from its own sources and no additional funds will be demanded from the Government in this regard:-

2. The incumbents of the above posts, who are in service on 30.06.2007, are granted one special increment w.e.f 01.09.2007.

3. The personal upgradation of posts would be subject to the following condition:-

- i) In future, no recruitment shall be made against the posts mentioned at Para 1 above including those already declared dying cadre.

- ii) In future, recruitment shall be made against the posts of Junior Clerk, Senior Clerk, Assistant and Superintendent instead of those mentioned in Para-1 above. However, the nomenclature of existing incumbents shall not be changed on the following grounds:-
- a) The post of Vernacular Clerk, Store Keeper, Record Keeper, Library Clerk and Sub-Divisional Clerk mentioned in Para-1 above exist at Government side and have not been upgraded on the analogy of Junior Clerk these posts are altogether different from Junior Clerk with respect to prescribed qualification, job description and hierarchy. Hence, these posts cannot be redesigned as Junior Clerk.
 - b) The posts of Octroi Inspector, Bus Stand Inspector, Tax Inspector, Goods Exit Tax Inspector, Rent Inspector, Inspector The-Bazari, Water Rate Inspector, Light Inspector, etc. mentioned in Para 1 above have no relevance with the post of Senior Clerk, Similarly, the posts of Assistant Taxation Officer, Assistant Octroi Superintendent mentioned in Para 1 have no relevance with the post of Assistant. These posts are altogether different from Senior Clerk and Assistant respectively with respect to prescribed qualification, job description and hierarchy. Hence, these posts cannot be re-designated as Senior Clerk and Assistant respectively.
 - c) The posts mentioned at Para 1 above carry BS-10, 11, 12, 13, 14, 15 & 16 whereas, the post of Superintendent at Government side carried BS-16 which was up-graded to BS-17 w.e.f. 01.01.2016. Moreover, the post of Garage Superintendent at Government side was earlier in BS-11 which was placed in BS-16. It has not been up-graded to BS-17 on the analogy of Superintendent. Hence, the posts mentioned at Para 1 above cannot be re-designated as Superintendent.
