Subject: **DISPOSAL OF MATTERS CONCERNING THE PUNJAB LAND USE (CLASSIFICATION, RE-CLASSIFICATION AND RE-DEVELOPMENT) RULES 2009 AND THE PUNJAB PRIVATE HOUSING SCHEMES AND LAND SUB-DIVISION RULES 2010**

I am directed to refer to the subject noted above and to say that in the wake of repeal of Punjab Local Government Ordinance 2001, the nomenclatures and terms used in the Punjab Land Use (Classification, Re-Classification and Re-Development) Rules 2009 and the Punjab Private Housing Schemes and Land Sub-Division Rules 2010 are not in conformity with the provisions of PLGA 2013, and therefore, it is imperative to take special measures to deal with matters concerning land use and private housing schemes till such time said rules are notified in terms of section 144 of the Act *ibid*.

2. Further directed to inform that the elected Local Governments are allowed, by invoking the provisions of section 155 read with section 154 of PLGA 2013, to perform their functions of land use and private housing schemes, *mutatis mutandis*, according to the Punjab Land Use (Classification, Re-Classification and Re-Development) Rules 2009 and the Punjab Private Housing Schemes and Land Sub-Division Rules 2010, till notification of the said rules under PLGA 2013, keeping in view the following:

- (i) The nomenclatures and terms 'City District Government' or 'TMA', 'TMO' and 'TO(P)' as used in the Punjab Land Use (Classification, Re-Classification and Re-Development) Rules 2009 and the Punjab Private Housing Schemes and Land Sub-Division Rules 2010, may be read as 'Local Government concerned', 'Chief Officer concerned', 'District Officer / Municipal Officer (Planning)', respectively;
- (ii) The District Planning and Design Committee (DPDC) notified by this Department vide Notification dated 09.03.2017 shall hold field for all intents and purposes of the said rules;
- (iii) All other provisions of the said rules shall, *mutatis mutandis*, apply to cases falling within the jurisdiction of respective Local Governments.

3. It is reiterated that above arrangements are purely temporary and subject to final notification of the Land Use and Private Housing Schemes Rules under section 144 of PLGA, 2013. Therefore, the provisions of abovementioned rules; and the
